General Meeting Minutes

The meeting called to order at 6:06pm

President's Report- Aaron Kaminski – 1) Aaron reminded team managers that we are re-mapping the way we communicate information to the teams (not just using the meeting minutes and will be deploying the website distribution process to push information directly to parents and players). Meetings for team managers will not be every month, with the next meeting scheduled in December. 2) Warned teams to watch carefully for coach ejections. President wants to be informed by the team manager when a coach is ejected from a game. 3) Discussed the potential partnership with CGCC to develop fields next to the existing CGCC that will be leased by GSC for our use. 4) For high school aged teams, soon you will be receiving our college preparation booklet and meeting with either Matt Smith (girls) or Tim Barmettler (boys) to review information available for you to prepare for college (DIV 1, 2, 3 NIA, etc.). This information will be available on our website. 5) Asked team managers to talk with parents about sideline behavior and to remind them that they have signed both the state and our club code of conduct forms.

Secretary's Report – Jon Ivanhoe - 1) On behalf of Rob Messer (tournament director) and Jim Cope (Assistant Tournament Director) Jon reviewed the tournament project describing progress to date and the need to conduct a kick-off with coordinator volunteers. Much work will need to be done and it's not too early to discuss with team parents their volunteer responsibilities. 2) The board passed a motion to allow our president the authority to move forward in an exploratory manner to pursue partnership with CGCC for field development.

Treasurer's Report – Kathleen Renshaw – 1) Reminded team managers/treasurers that they are responsible for paying coaches on time and generally the process is working. Checks can be mailed to GSC, PO Box 1060, Gilbert, AZ 85299-1060 Attention: Kathleen Renshaw. 2) Financial Statement for the club was provided to the board. 3) 2008-2009 GSC Scholarship list was provided to the board.

Registrar's Report – Lisa Lenkaitis 1) Reminded managers to be sure to have appropriate team name on all forms submitted to registrar, state league or got soccer. 2) Continue to engage Lisa early on any player add/drop or transfers.

Director of Coaching- Tim Barmettler - Not present – Corey Christensen provided an update to the board.

Uniform Coordinator- Stacie Gillaspie - Send Stacie an email if your team is missing any uniform stuff.

Field Coordinator – Bridgette Holbrook 1) Field Irrigation on 10/16. 2) Teams playing in Open League at GYSC are required to supply their own nets and flags. 3) Prepare players for mosquitoes for the next few weeks. Fields are sprayed every Monday and Every Thursday late.

Public Relations – Pam Jerome – 1) Good Arsenal Teal turn out for the ASU/UA Women’s soccer game in Tempe.

Webmaster – Steve Anderson - 1) Provide Steve with any player changes and updates for the team database. You can send these to webmanager@gilbertsoccerclub.org. 2) GSC will be able to link your existing team website to our club website. Ask Steve for instructions. 3) Go to AYSA home page and look for Risk management information to ensure that you are protecting your players (on your website) from predators.

GYSA Representative – Rob Messer - Not Present no update.

VYSL Representative - Ken McIntosh - VYSL has effectively disbanded with the exception of being used by extremely small clubs. We have a few teams in GSC that are taking advantage of playing some scheduled games in addition to Open state league.

New Business: 13 of 17 teams placed 3rd or better in last week’s Hammers Cup.
