## General Meeting Minutes

The meeting called to order at 6:03pm

President's Report- Rob Messer – 1) Rob spoke about the upcoming GSC Arsenal Challenge tournament. Currently 50 teams signed-up (12 from GSC) and this is around the same numbers from last December, Tournament is expecting to have around 220 teams. Registration deadline is 1/9/2009 and the “fighting” of schedules will be conducted by the coaches on 1/11/09. Venues will include GYSC, Discovery Park, Snedigar Sports Complex (south Chandler), probably Power Ranch and Highland HS. Rob announced Jim Cope as Assistant Tournament Director. Jim will become Tournament Director next season. Rob announced Dawn Zuber as Volunteer coordinator. Emails will go out to teams in early January reminded them to assign a team volunteer lead and to begin the slotting process. Ken McIntosh spoke of our sponsorship and selling ads program for the tournament program. Each team is expected to sell a minimum of \$400 ad space for the program. The deadline for ad submissions will be on 1/25/09 so that the program booklet can be printed. An email will be sent over the next few days to prepare teams for tackling this assignment. Check-in will be on Wednesday 2/18 at CGCC much like last year and the team managers will check-in their own teams and stay to check in other teams. 2) Rob spoke of the battle being waged over cancer by 92 Premier Arsenal Player, Jordan Perry and his family. The Arsenal Challenge tournament committee and board will be dedicating the tournament to Jordan and will be selling bracelets in his honor. Rob has bracelets available for all teams to sell to players, families and friends.

Secretary's Report – Jon Ivanhoe - 1) Reminded the assembly that our next scheduled General Meeting will be on Sunday, February 8<sup>th</sup>, 2009 at 6:00pm. It is at this meeting that we vote in a new board and that we also ratify any modifications to our by-laws. A separate email will circulate in late December or early January with open board positions. Anyone interested in serving on the board can be nominated by submitting his/her name into nomination via email to the club secretary (Jon Ivanhoe). The board will meeting in January on or about 1/11/2009 for an extended board meeting. More details will be sent out in late December or early January. 2) Two motions were passed by the board during the December meeting: First, the motion carried that we will keep our existing uniforms in the 2009-2010 season if OTC Sports or XARA can supply replacement pieces; and second, All uniform order communications with manufacturing supplier goes through the uniform coordinator and not the store merchant(s).
